What's New March 2024



Release 6.2a – Patch (Released 19 March 2024)

1. DRC Tax Tables

The Finance Law N°23/056 of 10 December 2023 for the 2024 tax year has been promulgated by the President. This law is effective as of 1 January 2024.

Please take note of the following changes applicable to payroll:

- Employers are expected to file the annual return by the 15th of February and no longer the 15th of January.
- Changes were made to the compensation of foreign employees. The remuneration for these employees may under no circumstances, be less than the guaranteed interprofessional minimum salary of the employees' home country.
- Gratuities given to salaried employees in cash accompanied by official testimonials and other honours they receive, are exempt from tax.
- The minimum tax value has been changed. The monthly IRPP cannot be less than 2,500.00 CFCA (formerly set at 2,000.00 CFCA).

Please Note:

This change has been applied to the Tax Tables.

• Permanent and non-permanent bonuses, snacks and other benefits paid to state officials and officials shall be taxed on remuneration at the rate of 3%.

Please Note:

You need to create a Deduction Line and Method of Calculation to accommodate this change. This is not available on the Tax Tables.

• Permanent and non-permanent bonuses, snacks and other benefits paid to members of political and similar institutions, the list of which is determined by regulation, are taxed on remuneration at the rate of 15%.

You need to create a Deduction Line and Method of Calculation to accommodate this change. This is not available on the Tax Tables.



2. Kenya: Post-Retirement Medical Fund Relief

The Finance Act of 2023 introduced a new relief called the Post-Retirement Medical Fund (PRMF) Relief, effective 1 January 2024. The relief is calculated as the lower of:

- 15% of the amount of contribution paid, or
- KES 60,000 per annum.

Please Note:

We note that although the relief is contained in the legislation, the Kenya Revenue Authority (KRA) has not provided us with a definitive confirmation that the relief may be granted on the payroll.

Furthermore, the PRMF relief has not been incorporated into the P10 iTax template. As a result, the P10 return does not provide for a field to claim this relief.

We therefore **caution employers** from claiming this relief on the payroll.

Employers who choose to claim the relief on payroll do so **at their own risk** and are aware that it might not be possible to claim the relief on the P10 return.

This may result in **tax differences** between the tax calculated on the payroll and what is submitted on the tax return.

Steps:

- Create a Deduction Line to accommodate this relief
- Access the **Africa Tax Rule Linking** from the **Main Menu** click on Payroll > Definitions > Africa Tax Rule Linking > <OK> Link to the applicable Tax Rule.

		Issues Resolved
RSA: IRP5 Printing	Exclusion Reason Code 04 was incorrect for Foreign Income Employees.	In Release 6.1a in September 2023, there was a change to the IT3a Reason Codes (4) for employees with Tax Status "No Tax" and Income against Taxable IRP5 codes. If this scenario occurred, a warning message was printed on the Validation Report.
		This resulted in employees with Tax Status "No Tax", flagged for Foreign Income and income against Taxable IRP5 Codes to also trigger this warning - which is incorrect. The IT3a Reason Code for these employees is a 05.
		We have amended this so that employees flagged for Foreign Income (FI), with Tax Status "No Tax" and income against Taxable IRP5 Codes, will not display a warning message.
		Please Note: Release 6.1b (Tax-Year-End Instance) as well as for Release 6.2a (Live Instance for current Tax Year) have been updated with this amendment.

1. RSA: Tax Related Changes

Tax Table has remained unchanged.

Prescribed Rate Per Kilometre

R4.84 per kilometre (increased from R4.64)

Please Note:

If you have entered Travel Transactions before updating to the current release, the rate per kilometre was calculated at R4.64. Delete these transactions and recapture them to apply the increased rate of R4.84/km.

2. RSA: other Important Payroll/Labour Related Changes

National Minimum Wage Increase

From March 2024, the National Minimum Wage rates will increase as follows:

- from R25.42 to R27.58 per hour,
- from R25.42 to R27.58 per hour for farm workers,
- from R25.42 to R27.58 per hour for domestic workers,
- from R13.97 to R15.16 per hour for workers employed on an expanded public works programme, and
- for workers who have concluded learnership agreements contemplated in section 17 of the Skills Development Act, new rates are indicated in Schedule 2 of the Government Gazette.

Please Note:

For Employment Tax Incentive (ETI) purposes, you must confirm that the correct minimum wage rate per hour is processed for each employee from 1 March 2024, to ensure the correct 'minimum wage test' is applied by the system.

OID Maximum Earnings

The OID limit for the 2023 assessment period (March 2023 - February 2024) is R568 959. The OID limit for the 2024 assessment period (March 2024 – February 2025) has yet to be published.

It is your responsibility to amend the OID earnings threshold in the first pay period for March 2024 on: Main Menu > Company > Basic Company Information > OID Annual Limit entry field.

3. OID Report Changes

The amended Compensation for Occupational Injuries and Diseases Act (COIDA) of 2022, was promulgated on 17 April 2023. The Department of Employment and Labour have published the "ROE explanatory memorandum" for which they provided guidance on how to report earnings calculated to complete the ROE form. These amendments directly affect the payroll.

Maximum Earnings

The return of earnings (ROE) explanatory note for the 2022 reporting season (Government Gazette No. 48337) has provided guidance on how the annual maximum earnings should be applied:

- The limit is an annual limit and should not be pro-rated as a monthly figure.
- The annual limit must be applied to earnings irrespective of whether the employee worked for less than 12 months.

This means the maximum earnings should be the lessor of actual earnings and the annual limit.

The Fund did not clarify how the monthly earnings must be reported for the purpose of the manual ROE submission, but we applied the following calculation method:

- If the employee's/director's earnings are greater than the maximum annual limit, the monthly earnings should be the maximum annual limit divided by period of service.
- If the employee's/director's earnings are less or equal to maximum annual limit, the monthly earnings should be the actual monthly earnings.

The employer is given an option to apply either an average count or a total headcount of employees and directors employed during the year.

8. Zimbabwe: Tax Rule Changes

ZIMRA has informed us that "ZWL figures for tax credits, exemptions and deduction limits are no longer applicable, the US\$ figures shall be converted to ZWL if the salary is in ZWL".

The following USD values should be converted to ZWL when calculating PAYE:

- Pension deduction: limited to USD 5 400 per year.
- Elderly person, blind person & mentally or physically disabled person tax credits: USD900 per year.
- Bonus exemption: USD400 per year.
- Retrenchment Package exemption: Higher of USD 3 200 or 1/3 of package up to USD15 100 per year.

To accommodate the above-mentioned change, you need to:

- Save the Exchange Rate.
- Create calculations to convert US\$ to ZWL.
- Review the linking on the Africa Rule Linking (AFL) Screen.

Please Note:

Pension Deduction Limit, Tax Credit and Bonus Exemption values can fluctuate during the year if the exchange rate used in the calculations is fluctuating.

9. RSA: Employment Verification Services (EVS)

The following feature is only available for **RSA Tax Countries**.

Employment Verification is a new benefit for your employees without any cost to you or to them and will be available for your employees through several trusted partners. Employees take control of their data to be shared for credit applications, while you save time and can be more confident with a secure, automated data transfer.

10. RSA Public Holiday

The President of the South Africa published Proclamation Notice 157 of 2024 declaring 29 May 2024 as a public holiday.



11. System Changes

Two-factor Authentication (2FA)

Company Selection Screens (e.g. ACB Export)

Some of the system screens had a misalignment of headings and columns. This was because the Header was a grid, and the body of the table was a list box.

We have amended the appearance of these screens and in some instances the functionality.

The most used screen of this nature is the Company Selection Screen at Export time, e.g.: ACB Exports.

As from Release 6.2a:

- The header and body of the table are part of one grid.
- Once you have completed the export for the first company, the company you are in, will be removed from the Company Selection list, and only the companies that are set up for the same ACB will be displayed on the Company Selection list.


